FOREWORD



The new 7 years long programming period started in the European Union in 2014 that has paved the way to the largest economic stimulus and development program ever.

Almost 12 thousand billion Hungarian Forint EU development funds are coming to our country and 60% of this amount will be spent directly on economic development by the Hungarian Government.

New jobs shall be created, the research activities and innovation shall be supported, the industrial developments shall have a priority and support shall have a strong focus on SME's.

The Central European Region is hopefully to be expected to become the growth engine of Europe Our results from the past few years justify that Hungary shall became the fastest growing economy in the European Union.

One of our most important objectives is to reach full employment by 2020 via providing the job opportunity for everyone who intends to work. We shall apply EU funding as prudent owner to achieve that objective.

The industrial development and reindustrialization shall be the main objective in the next 7 years what is fully in line with the EU 2020 strategy. As a result we expect that the added value contribution to the total GDP shall increase from 20 percent up to 30percent.

The main focus of the Hungarian economic policy is to improve the competitiveness of the SME's. The enterprises shall be supported via focused actions adjusted to their life-cycle and unique production factors.

We shall promote youth entrepreneurship and the creation of new enterprises. In addition clusters and other business cooperations shall be strongly promoted in order to increase the number of successful enterprises operating on international markets.

'Research and development' has never ever received such a large amount of development funding as the sector is to be supported in the next 7 years. Supporting the national research infrastructure directly increases the Hungary's competitiveness, therefore determines the level of her development. The creation of new research centres are to be promoted, and also it is an important objective to integrate domestic enterprises, research institutes or universities into the single European research networks.

As for IT development, the Hungarian government aims to develop the whole domestic digital environment. The broadband internet shall be accessible in every household until 2018 as a result of the program implementation. Due to the spread of digital literacy the life quality of individual citizens shall rise, while the widening of the digital economy increases the competitiveness of our country as well.

Hungary aims to reduce the emission of domestic manufacturing processes and aims to increase energy efficiency by joining the European Union's efforts against climate change. All the above activities contribute to the reduction of environmental burdens and the energy demand of production processes, and thus the external energy dependency of the country shall be reduced.

Our objectives might seem ambitious, however, investing much work and expertise alongside the economically and socially beneficial utilization of development funding, we can contribute to a well-developed and competitive future Hungary together.

I wish to all of us much creativity, persistence and even more success in reaching these objectives.

Hungary started to implement Jeremie in 2007 with a holding fund structure. The Managing Authority launched the first open calls (microcredit and guarantee) in autumn 2007 and after a notification procedure with the Commission they finalised a tender for venture capital in July 2009.

SECTION TOPICS

I. CHALLENGES OF THE 2014-20 PROGRAMMING PERIOD

Closing the old and launching the new programmes is a double challenge for the Member States. The new programming period launched new methods and approaches in several fields. The gained experience from previous years can help tackle these challenges.

Topics to be discussed in the panel are the followings:

- In the 2007-13 period was there any measure, or applied method which you consider as a good practice for other Member States? What was the biggest challenge for your organisation in the previous period?
- What is your opinion about the compulsory use of thematic objectives at the planning of financial sources in the 2014-20 period? Which thematic objective(s) were used at your competitiveness OP? Did this approach mean any challenges at the planning phase compared to the previous period?
- Will you use any new tools or methods in your new competitiveness OP compared to the previous OP? What are the main differences between the two OPs? What are the main changes in the new program compared to the old one?
- The financial crisis in 2008-09 made necessary an at least partial redesign of most of the competitiveness OPs. How did you take into consideration this experience at the new programming period?

II. FINANCIAL INSTRUMENTS WITHIN THE OPS OF 2014-20 COMPETITIVENESS PROGRAMMES

In the new programming period the Commission intends to place particular emphasis on encouraging the implementation of financial instruments. Financial instruments play an important role in the achievement of cohesion policy objectives by enabling public sector resources to be used in a more efficient way by attracting private investors to finance the identified market gaps and thus providing significant multiplier effect.

Topics to be discussed in the panel are the followings:

- What are the major achievements, lessons learnt and challenges, in particular focusing on eligibility in relation to the closure process of FEIs in 2007-13?
- How do legacy resources (residual funds) from the 2007-13 programming period work and are these planned to be reused?
- What are the main differences between the programming period 2007-13 and 2014-20 in respect of the implementation structure and actors?
- What type of new products are to be launched in 2014-20 based on ex ante assessments (concerning target groups, scope, financing gaps, etc.)? What types of indicators will be used in order to measure the performance of Fls?

III. RISKS IN AUDITING WITH REGARD TO THE PROJECT CHANNEL

The main expectations of the Commission for the next programming period related to strengthening the management and control system can be foreseen already from the audit experience of ERDF from the programming period 2007-13.

Topics to be discussed in the panel are the followings:

- What changes in policy and processes came about in the management and control system as a result of the Commissions controls during 2007-2013?
- Have these changes in policy and processes fulfilled the expectations? Have they managed to treat the discovered risks or did they result in the emergence of new risks? What recommendations would you give to the Commission in this respect?
- For the 2014-2020 programmes a further strengthening of anti- fraud measures is expected. What actions could be proposed for your consideration?
- One of the main topics in the audits is avoiding overpricing. It is expected that for project budgets average market prices should apply. How can market price be determined in your practice?
- Please share your practical experience with the Simplified Cost Options (SCOs) method!

IV. REDUCING DIFFERENCES IN REGIONS AND SUB-REGIONS

In most cases the Competitiveness Operational Programmes are financed by the European Regional Development Fund (ERDF). ERDF aims to strengthen economic and social cohesion in the EU by correcting imbalances between its regions.

Topics to be discussed in the panel are the followings:

- What is your opinion regarding the success of the Operational Programmes (2007-2013) in reducing regional differences? Based on the available interim data did regional differences reduce, stagnate or increase as a result of measures of the last programming period?
- Economic performance has a tendency of concentration in central regions (capital cities), but only a small fraction of available financial resources can be used in these regions. How does this contrast affect the 2014-20 programming period and how can it be managed?
- Are you planning to use completely new methods to help less developed regions catch up? If yes what are they?
- Should less developed regions be supported by specific programmes to manage regional differences in a country or developed regions should be supported claiming that through the multiplicator effect economic growth will follow in less developed regions?
- How will conclusions of S3 strategies be applied practically in the measures of the 2014-20 programming period? What is the relevance in using S3 strategies in the less developed regions?
- Can large companies have a special role in supporting less developed regions to catch up?
